112. ANNUAL MONITORING REPORT 2008 AND UDP 'SAVED' POLICIES

The Committee considered the report of the Planning and Economic Regeneration Director on the progress of the Local Development Framework by monitoring a range of indicators. The report went on to explain that the Unitary Development Plan (UDP) Policies were saved until June 2009. The Department were required to agree which policies were to be saved beyond June 2009.

A list of the policies the Planning Department was seeking to save was provided at Annexe A, policies the Department did not seek to save was provided at Annexe B.

RESOLVED: That

113. SITE WASTE MANAGEMENT PLANS

Further to Minute No.47 of the meeting of Cabinet Member – Environmental held on 22 October, 2008 the Committee considered the report of the Environmental Protection Director advising of the compulsory requirement for Site Waste Management Plans (SWMP) for developments costing more than £300,000 and recommending the regulatory approach to be adopted by the Council.

The report indicated that following extensive consultation by DEFRA in 2007, SWMPs were now compulsory for larger construction projects; that the aims of SWMP process was to ensure that developers and contractors in the construction and demolition sectors did more to manage their wastes by improving materials resource efficiency and reducing fly tipping.

The report detailed the SWMP requirements; indicated that a range of offences were included in the SWMP Regulations, together with the enforcement powers given to Local Authorities; Sefton's approach to SWMPs and that a standard condition had been produced to impose on the grant of planning permissions; and concluded that specific training on SWMPs would be required for enforcement officers.

RESOLVED:

That the decision of the Cabinet Member – Environmental to approve the Site Waste Management Plan Regulations, as detailed within the report, be noted.

114. ENSURING CHOICE OF TRAVEL SUPPLEMENTARY PLANNING DOCUMENT - ADOPTION

The Committee considered the report of the Planning and Economic Regeneration Director that sought approval to adopt the 'Ensuring Choice of Travel' Supplementary Planning Document (SPD). The report informed of the results of the formal public consultation on the SPD. The SPD would form one of the Local Development Documents within Sefton's Local Development Framework. It would replace the existing Ensuring Choice of Travel Supplementary Planning Guidance Note.

The SPD was identified in the Local Transport Plan for Merseyside (2006-11) as a critical element of the plan and it highlighted the importance of the document to make sure that sustainable transport issues were thoroughly considered in new developments. The aim of the SPD was to provide a consistent framework for assessing accessibility across Merseyside.

RESOLVED: That Cabinet be recommended to:

- (1) revoke the Ensuring Choice of Travel SPG; and
- (2) adopt the Ensuring Choice of Travel SPD and the Sustainability Appraisal Report and the Appropriate Assessment screening statement for the SPD.

115. DEVELOPMENT CONTROL PERFORMANCE

The Committee considered the report of the Planning and Economic Regeneration Director that advised of the Planning Department's

performance in dealing with planning applications, appeals, and related matters for the third quarter of 2008.

116. CORE STRATEGY - PROGRESS REPORT

The Committee considered the report of the Planning and Economic Regeneration Director that provided an update on progress on the preparation of the Core Strategy.

The report also sought the Committee's advice on the choice of a slogan for use in publicising the Core Strategy. Councillors discussed the suggested 'Your Sefton – your future', and decided they preferred 'Our Sefton – our future' as a slogan to promote the preparation of the Core Strategy in all correspondence and on the Council's Local Development Framework internet web pages.

RESOLVED: That

- (1) the Core Strategy Progress report be noted; and
- (2) the slogan 'Our Sefton our future' be adopted as a slogan to be used to promote the preparation of the Core Strategy in all correspondence and on the Council's Local Development Framework internet web pages.

Further to Minute No. 46 of the meeting of the Sefton East Parishes Area Committee held on 6 November 2008, the Committee considered the report of the Planning and Economic Regeneration Director that advised of the result in relation to the implementation of an appointment system and closing weekly planning surgeries at Maghull and Formby libraries for a trial period.

That the discontinuation of both weekly surgeries at Maghull library and Formby library on a permanent basis be approved.

119. REVENUE AND CAPITAL EXPENDITURE MONITORING TO 30TH SEPTEMBER 2008

The Committee considered the report of the Planning and Economic Regeneration Director that provided the Committee with the quarterly forecast position, based on information as at the 30th September 2008, in relation to the Portfolio's 2008/9 Revenue Budget.

Members discussed pressures on the Planning budgets this year and the initial forecast overspend of around £200,000; the downturn in the number of major planning applications which would disproportionately affect fee income; as well as the ongoing statutory requirements that were previously supported by 'Planning Delivery Grant', but now to a much lesser extent by the replacement 'Housing and Planning Delivery Grant', which were putting pressure on the Departments budgets this year.

RESOLVED: That

- (1) the progress on the Planning Portfolio's revenue budgets that were subject to risk-based monitoring be noted; and
- (2) the Cabinet and the Overview and Scrutiny (Regeneration and Environmental Services) be requested to consider the pressures on the Planning Department's budgets.

120. WORKS IN DEFAULT WITHIN QUEENS ROAD/BEDFORD ROAD HMRI AREA

The Committee considered the report of the Planning and Economic Regeneration Director that sought authority to carry out works in default in respect of non compliance with a notice under the terms of Section 215 of the Town & Country Planning Act 1990 to the following property within the Queens Road/Bedford Road HMRI area – 51 Hawthorne Road, Bootle.
