STATUTORY DECLARATION

3. I do not acknowledge that any public rights of way cross my land.
4. No ways have been dedicated over the land edged red on the plan exhibited accompanying this declaration since I took ownership on 30th November 2005 and I declare that I do not intend dedicating any public right(s) of way across the land in my ownership shown edged red nor / including greater rights such as (but not exclusively) rights of way of higher status such as bridleways or byways open to all traffic.




