## **RE: Sefton Council Annual Consultation on Care Home Fees**

I am writing to you in order to commence formal Sefton Council consultation with you on our proposed fees for the 2025/26 financial year.

The Council are proposing an **8.03%** increase to fees which if approved, would result in the following rates being implemented (with effect from 1<sup>st</sup> April 2025) to the Council's contracted rates.

The following table outlines how the increase has been calculated.

Enclosed with this letter a document that provides a full breakdown of the calculated rates by each cost element.

Please also note the following.

- Nursing figures do not include Funded Nursing Care.
- Where a care home provider charges a rate above the Sefton contracted rate resulting in a Top-Up payment being paid by the Council ('Sefton Pays Top-Up') this Top-Up payment will not be subject to the 8.03% increase.
- Any currently paid 'Above Standard Rate' payments will not be subject to the 8.03%

- increase.
- Any existing placements which are costed based on an individual Resident assessment may be increased based on the same percentage uplift detailed in the table above, but going forward such rates will be subject of analysis via a costing tool being implemented in Sefton.
- Fees will be applicable from 1st April 2025.

As part of the consultation process the Council wishes to particularly receive and consider your feedback in relation to the following questions.

- 1. Whether the level of proposed fees set out will cover the cost of meeting assessed care needs within an efficient residential/nursing home for the period from 1<sup>st</sup> April 2025 to 31<sup>st</sup> March 2026; and
- 2. If you do not agree with the above rates and if you consider that they will not cover the Care Act 2014, the cost of meeting assessed care needs within an efficient residential/nursing home, please outline why and provide any supporting information that you feel may be pertinent.

The following plan/timeline outlines the next steps of the Consultation and decision-making process.
