

Guidance Notes on Building Regulation Charges

(Effective from 1st April 2026)

Domestic Extensions and Alterations

The charges for Building Regulation work are intended to cover the cost of the service. There are two methods that we may use to establish the charge for building work: -

- ▶ Individual assessment for an application and
- ▶ the setting up of a standard charge

Standard Charges

The following tables can be used to calculate the relevant charge for your application to build new dwellings.

These charges have been assessed on the basis that:

- ▶ the building work does not involve innovative or high-risk construction techniques (details available from our team).
- ▶ the building work takes no longer than 3 years from the date of application to completion of the works.
- ▶ the design and the construction are undertaken by a person or company that is competent to carry out the project.

Individual Assessment of a Charge

Charges are individually determined for any domestic building works not contained within the tables.

If your work is not listed and requires an assessment of the charge, then please e-mail us at building@sefton.gov.uk detailing the proposed work and we will contact you within one working day. **Alternatively, if you are doing more than one element of work you may be eligible for a discount. Reductions of certain fees

	Reason for reduction	Reduction in Charges shown in Schedule 2 when that work is being carried out at the same time as any work shown in categories 1 – 9
A	Installation or replacement of windows and or doors in a dwelling-house (under 12 units).	50% of the Full Plan or Building Notice Charge
B	Where the work comes within the scope of Schedule 2 and the estimated cost of the building work is less than £5,000.	50% of the Full Plan or Building Notice Charge

#	Where the work is as described in category 19 (above) and the applicant can provide an acceptable test certificate in accordance with BS7671 for the work and the Authority does not have to test the electrical work. This Charge will be reduced to £255.00 + V.A.T.
